#### I. METHOD OF ACQUISITION

This Statement relates to a proposed acquisition of control of Fremont Insurance Company (FIC), a Michigan domestic stock insurance company. FIC's principal address is 933 East Main Street, Fremont, Michigan 49412. ACIA will acquire FIC in a merger transaction between ACG Acquisition Co., Inc. (a business corporation formed by ACIA solely for the purpose of enabling the transaction described herein, referred to herein as "Merger Sub") and FIC's parent company, Fremont Michigan InsuraCorp, Inc. (FMIC). ACIA is a Michigan domiciled reciprocal inter-insurance exchange. A Board of Governors consisting of 13 members controls ACIA.

The acquiring party in this transaction is ACIA (Applicant). The Applicant intends to acquire direct control of FIC pursuant to an Agreement and Plan of Merger, dated as of April 15, 2011 (Agreement) by and among the Applicant (Purchaser), Merger Sub, and FMIC. The transaction will consist of the merger of Merger Sub with and into FMIC, after which FMIC will continue as the surviving corporation and will be renamed ACG Fremont InsuraCorp, Inc. (Surviving Corporation). The Surviving Corporation will be the sole shareholder of FIC, and ACIA will be the sole shareholder of the Surviving Corporation. A copy of the Agreement is attached hereto as Exhibit A, and is incorporated herein by reference.

The consideration for the proposed merger transaction (Merger) will consist of ACIA's payment of thirty-six dollars and fifteen cents (\$36.15) per share for all shares of the Class A common stock of FMIC (FMIC Shares) that are outstanding on the date that the Merger is effective (aggregate price of sixty-four million, five hundred twenty-nine thousand, four hundred forty-nine dollars (\$64,529,449)), plus ACIA's payment of the amount necessary to effect the cancellation of all outstanding options for the acquisition of FMIC Shares (aggregate price of three million, one hundred sixty-one thousand, five hundred five dollars (\$3,161,505)). The total aggregate purchase price for the Merger will be sixty-seven million, six hundred ninety thousand, nine hundred fifty-four dollars (\$67,690,954)). This amount will be payable as described more thoroughly in Item IV below.

It is anticipated that the closing of the Merger will occur (a) within two business days following the satisfaction or waiver of all conditions precedent set forth in the Agreement, including the approval of this transaction by shareholders of FMIC owning no less than a majority of the outstanding FMIC Shares, compliance with the requirements of the Hart-Scott-Rodino Antitrust Improvements Act, and the approval of this Form A by the Michigan Office of Insurance Regulation, or (b) such other date as the parties may agree.

The Applicant, Merger Sub and certain shareholders of FMIC owning approximately sixteen percent (16%) of the outstanding FMIC Shares have entered into a Shareholders Agreement, dated as of April 15, 2011 (Shareholders Agreement) pursuant to which such FMIC shareholders have agreed to vote to adopt and approve the Agreement and to take certain other actions in furtherance of the Merger. A copy of the Shareholders Agreement is attached hereto as Exhibit B, and is incorporated herein by reference.

This Statement is submitted for the purpose of obtaining the approval of the Michigan Commissioner of Insurance for the proposed acquisition pursuant to Section 500.1311 of the Michigan Insurance Code (the "Code") and the applicable provisions of the Michigan Insurance Regulations.

#### II. IDENTITY AND BACKGROUND OF THE APPLICANT

ACIA's principal business is underwriting insurance. ACIA conducts its business directly and through several subsidiary stock insurers. Being a reciprocal insurer, ACIA has no shareholders. ACIA's subscribers (policyholders) have granted powers of attorney to ACIA's corporate attorney-in-fact, Auto Club Services, Inc. (ACS), a Michigan domestic general business corporation. Other than the Board of Governors, no other person controls ACIA. ACIA writes personal lines property and casualty coverage, and is a licensed insurer in the states of Illinois, Michigan, Minnesota, Nebraska, New Hampshire, New York, North Dakota, Pennsylvania and Wisconsin. The present organizational structure of ACIA is shown on the chart submitted as Exhibit C and incorporated by reference herein.

## (c) <u>Organization Chart.</u>

The chart attached hereto as <u>Exhibit D</u> lists the present identities of, and the interrelationships among, the Applicant and all persons known to be controlled by or affiliated with the Applicant. FIC's business records will be kept and available at its principal place of business in Fremont or at ACIA's principal place of business in Dearborn, depending upon the nature of the record. It is anticipated that the Surviving Corporation will be merged into ACIA within 3 years following the transaction, with the result that FIC will be a direct and wholly-owned subsidiary of ACIA.

## VI. VOTING SECURITIES TO BE ACQUIRED

FMIC currently owns all issued and outstanding shares of sock of FIC.

The authorized capital stock of FMIC consists of ten million (10,000,000) shares of capital stock consisting of: five million (5,000,000) shares of Class A common stock, voting and without par value (FMIC Shares); five hundred thousand (500,000) shares of Class B common stock, non-voting and without par value; and four million five hundred thousand (4,500,000) shares of preferred stock, without par value. Currently, one million seven hundred eighty-five thousand forty-seven (1,785,047) FMIC Shares are issued and outstanding, no shares of the Class B common stock are issued and outstanding, no shares of the preferred stock are issued and outstanding, and two hundred seventy thousand one hundred fifty-nine (270,159) FMIC Shares are reserved for issuance under the FMIC stock plans, of which one hundred forty-eight thousand eight hundred twenty-four (148,824) FMIC Shares are subject to outstanding options.

As a result of the proposed transaction, (a) all of the issued and outstanding stock of Merger Sub shall be converted into validly issued, fully paid and nonassessable shares of common stock, without par value, of the Surviving Corporation, and (b) all the authorized, issued and outstanding shares of stock and stock options of FMIC will be cancelled. ACIA will become the sole shareholder of the Surviving Corporation, which, in turn, will be the sole shareholder of FIC. The terms, conditions and process for converting the capital stock of Merger Sub into capital stock of the Surviving Corporation and for cancelling the FMIC Shares and FMIC stock options are set forth in the Agreement previously identified as Exhibit A. Following the Merger, the former shareholders of FMIC will surrender their FMIC Shares to paying agent established pursuant to the Agreement in exchange for payment to such shareholders of the cash consideration described in Item I above, and the holders of the FMIC stock options will be paid the consideration for such options also described in Item I.

The terms of the acquisition were arrived at through arm's length negotiations between ACIA and FMIC. ACIA obtained a fairness opinion that the purchase price to be paid by ACIA is fair from a financial point of view to ACIA. This opinion was provided by the firm of Sherman & Company Holdings LLC, which firm ACIA retained to serve as its financial advisor.

#### VII. OWNERSHIP OF VOTING SECURITIES

FMIC is a publicly traded holding company. Except as set forth in this Statement, neither ACIA nor any of its affiliates or any of the persons listed in Item III has a beneficial interest in or the right to acquire a beneficial interest in such voting securities.

# VIII. CONTRACTS, ARRANGEMENTS OR UNDERSTANDINGS WITH RESPECT TO VOTING SECURITIES OF THE INSURER

The Agreement previously identified as <u>Exhibit A</u> and the Shareholders Agreement previously identified as <u>Exhibit B</u> reflect the current contracts, arrangements and understandings of ACIA regarding the proposed Merger. Except for the Agreement and Shareholders Agreement, there are no contracts, arrangements, or understandings directly or indirectly relating to any voting securities of FMIC or FIC involving ACIA, any person controlled by, or under common control with ACIA or any person listed in Item III, including but not limited to transfer of any of the securities, joint ventures, loan, or option arrangements, puts or calls, guarantees of loans, guaranties against loss or guarantees of profits, division of losses or profits, or the giving or withholding of proxies.

## IX. RECENT PURCHASES OF VOTING SECURITIES

Other than as set forth in this Statement, there have been no purchases, direct or indirect during the twelve (12) calendar months preceding the filing of this Form A Statement of any voting securities of FMIC or FIC, which were effected by ACIA, any person controlled by, or under common control with ACIA, or any person listed in Item III.

#### X. RECENT RECOMMENDATIONS TO PURCHASE

Except for the Agreement and the Shareholders Agreement, neither ACIA, nor any person controlled by, or under common control with ACIA or any person listed in Item III, or to the knowledge of ACIA any other person based upon interview or at the suggestion of ACIA, any person controlled by, or under common control with ACIA or any person listed in Item III, has made any recommendations to others to acquire any shares of the voting securities of FMIC or FIC during the twelve (12) calendar months preceding the date of this Form A Statement.

## XI. AGREEMENTS WITH BROKER-DEALERS

There are no agreements, contracts or understandings with any broker-dealer as to the solicitation of voting securities of FMIC or FIC for tender.
